Regulations:

- To register, submit attached form and registration fee. Space available on a first pay basis. Should you need to cancel during the year, a refund will be made at any time **except the last three weeks before the show.**
- Space cost: **\$50** per 2 ½ by 6' table and chair. Approximate size of the total booth space is **8' long and 6' deep.** This allows 1' at each end of the table and 3' in back of the table. As many table spaces may be purchased as are needed. Table and chairs are provided. Additional chairs are available at no extra cost. A 2.75% handling charge will be assessed on Credit Card payments.
- Only merchandise handcrafted by you is to be in the show—no imports & no commercial exhibitors.**
- Display items: Sturdy, free-standing aids no higher than six feet are considered safe. Only the wall spaces have access to the few electrical outlets that are around the perimeter of the rooms. No electrical cords can be taped to the floor which then cross aisles. If you desire more lighting, check out battery-powered units available at camping or automotive stores. This may work for you.
- Concessions are available. Only nonprofit organizations (that do not need certified kitchens) or those with certified kitchens may sell baked goods if they like, but not hot foods that are carried from home. These are Tri-County Health Department regulations.
- We are required to submit a list of vendor names, their addresses and their special event sales tax license number to the Colorado Department of Revenue for each of our bazaars. If you do not have a license already, please be sure to email us the number at ACHScrafterinfo@gmail.com once you received it. You can obtain the application at www.colorado.gov/tax. It may take up to 4-6 weeks to get your license. If you have any questions, please call the state at 303-866-5643 or 303-238-7378. Tax charts are available at the Registration table.
